THE OPPORTUNITY ZONE Program

The Opportunity Zone Program is a federal tax incentive designed to encourage investment in economically distressed communities. It aims to revitalize these areas by attracting capital and promoting economic development.



KEY ASPECTS of Opportunity Zone Funds



Tax Incentives

- **Deferred Taxes:** Capital gains taxes on reinvested earnings can be deferred.
- **Tax Exemption:** Investments held for at least 10 years may be exempt from capital gains taxes on profits.
- **Step-Up in Basis:** Additional tax benefits for long-term investments.

Economic Development

- **Growth & Jobs:** stimulates growth and job creation in underdeveloped areas.
- **Community revitalization:** attracts capital to economically distressed zones.

Investment Criteria

- **90% Allocation:** At least 90% of assets must be in Qualified Opportunity Zone properties or businesses.
- **Diverse Opportunities:** This includes real estate, business expansions, and infrastructure projects.

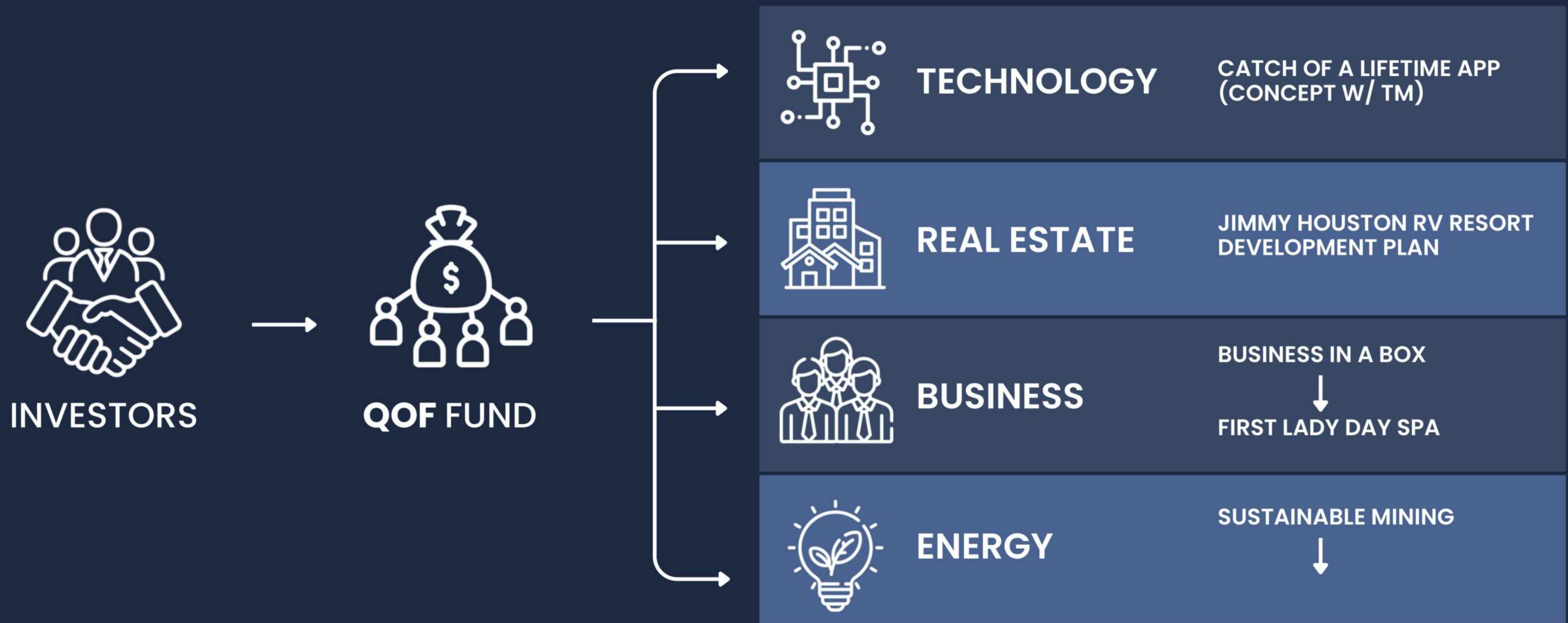
